Project Summary:

The program aims to instill awareness in the community. Awareness topics were reached based on discussions and focused meetings held with farmers' associations, the Directorate of Agriculture and the Directorate of Water Resources, as well as the Environmental Department in the targeted areas. Activities are implemented based on suggestions from stakeholders to ensure the most appropriate and efficient response to the needs, and local gaps in assistance.

The Ministry of Health has implemented a series of activities aimed at strengthening and improving public relations with the local government and the community as well as enhancing the community's role in preserving the environment and water resources in particular by increasing the culture of the population in the targeted areas.

The Ministry of Health sensitized 1,500 people within the urban areas of Tikrit district, through door-to-door field visits method.

Awareness topics:

1. Awareness about organizing and directing water consumption in the correct ways and preserving water in different ways, and the necessity of educating citizens about the importance of water, and the importance of reducing water use.
2. Conserve water by maintaining water pipes (open the tap only when needed, and close it tightly when you are finished using it).
3. Irrigate indoor plants in the simplest way and without wasting water, by using water from washing fruits and vegetables to irrigate plants in the home garden.
4. Home gardens, ways to get rid of them and the harms of over-irrigation Watering plants early in the morning, or at sunset, in order to avoid significant water evaporation, which forces the family to increase the number of irrigation times until the plant gets its needs.

Using modern means, for example, drip irrigation to conserve water, and using modern .5 irrigation methods, especially drip irrigation, in order to avoid losing a lot of water, thus saving it, and rationalizing the use of water for agriculture.

2. Project Name:

Expanding the empowerment of girls and women through IT and coding education in Shatt al-Arab, Basra, Iraq

Project Code: MH-P#2

DONOR: CFLI / 2

Project Summary:

The project aims to achieve full sustainability of IT and coding education in the ten schools targeted in the project implemented in 2021, which will allow these schools to integrate the content into their curricula and independently implement coding classes to empower girls. In the meantime, it aims to expand the scope of the intervention by targeting the Al-Noor Institute for Girls with Disabilities in Basra. The Ministry of Health will provide IT/Coding advanced and basic classes for a total of 170 girls (ages 12-13), 150 in the ten government schools (advanced) and 20 in the institute (basic), taught in Arabic for four days a week, For four months, with five courses (1.5 hours per term) each month. In each course, two groups of 15 students will attend two days a week. A total of ten teachers and two volunteers from the institute will be trained on IT/coding two days every month for three months (two-hour sessions). The classes will target students in Year 7, who are at risk of dropping out, and girls with disabilities at the institute, often excluded from IT classes due to stigma and lack of specialist support. You will use Scratch Classroom, designed for young learners and a tailored curriculum. Modules will cover basic computer skills, programming, creating simple games, teamwork and creative and analytical thinking. Furthermore, one women and girls empowerment session and one gender awareness session in the field of ICT will be organized in schools, with the participation of local women leaders, female ICT workers, local authorities, community leaders, and the general community. Long-term outcomes include that 170 girls in Shatt al-Arab will gain IT/coding skills, improve their ability to succeed in education and future employment and develop their own potential. Furthermore, the local community will demonstrate positive and transformative gender role models.

It is expected to draw attention to the issue of lack of IT skills among secondary school girls and Shatt al-Arab teachers, including girls with disabilities from Al-Noor Institute in Basra. Schools in the area have it as part of the curriculum, but the course is rarely implemented because the schools lack computers and trained teachers. In south-central Iraq, 94% of young women aged 15-24 have no ICT skills, with 25% illiterate (UNICEF, 2020). Only 47% of girls in Iraq complete middle school; In Basra, only 42% of students complete this level. Furthermore, girls with disabilities are often excluded from school because their education is not considered a priority. These multidimensional issues contribute to limited employment opportunities for girls and women; In Basra, approximately 25% of young people are unemployed; Across the country, only 12% of women participate in the labor market (IOM, 2019).

In parallel with the media campaign, the program provides a training guide on best practices. In developing and implementing communications and social mobilization activities, the partner contact point from each of the four governorates (Basra - Erbil - Dohuk - Baghdad) will participate in concluding the campaign and social mobilization activities that were designed to deliver the main messages to encourage the enrollment of girls in society. Each two-day training is paid and covers... This training is based on behavioral and social change communication curricula, in partnership with the Directorate of Education in the governorate.

The project aims to advance the women, peace and security agenda in Iraq by increasing women's representation in post-conflict governance, improving government, responding to sexual and gender-based violence against women, securing women's economic and social rights, and prioritizing gender equality in Iraq. Hands of Mercy will achieve this through roundtables/debates in Baghdad on the Vice President, Women, Peace and Security Law among women activists, lawyers, NGO representatives and government representatives; Produced and disseminated widely across social media, the web series focused on how to improve women, peace and security in Iraq; Distributing brochures throughout Baghdad to enhance community knowledge regarding women, peace and security at home and outside the family.

Support and motivation learning in primary schools, leaving no child behind in education: supporting the school, enrolment of Basra's most vulnerable children.

Project Summary:

The importance of the program in addressing the identified problem.

Half of Iraq's population is under the age of 19, one of the youngest populations in the world, and after decades of conflict and political and economic instability, young people and children, too often, experience overcrowded and deteriorating school environments and lose years of education. Nearly 3.2 million school-age children are still out of school. Several challenges affect children's access to education: the cost of education expenses, children's lack of interest in school, disability or health issues, and children working for family income support, gender norms,



and (perceived) protection concerns, such as unsafe routes to schools or lack of separate water, sanitation and hygiene facilities. Also, just over half, 93% of children enrolled in primary school, complete education. Furthermore, gender disparities exist within the education system: fewer girls are in school than boys, girls have lower literacy rates, higher dropout, lower attendance rates and lower completion rates among girls. Also, at all levels of education, there are more out-of-school girls than boys: in particular 65% of primary out-of-school children are girls, and 56% of out-of-school secondary-age children are also girls⁸. Gender norms also reinforce the role of girls in the family as caretakers, wives and future mothers, which increases parents' reluctance to send girls to school. As a result, girls have lower literacy rates, lower participation in the formal employment sector and greater exposure and increased risk of early or forced marriage. Moreover, in Iraq early marriage is particularly prevalent among women, with 27.9% of girls married at the age of 18 or younger. This increases the rate of increase in poor households to 30% in the poorest two quintiles of the population.

The number of beneficiaries: 2,600 children between the ages of 6 and 17 years, 50% of whom are girls, including children with disabilities when present, 70 families from OOSC, 10 teachers, OOSC parents and family members, vulnerable communities in Basra.

The proposed intervention aims to respond to the most pressing educational needs of adolescent girls in Basra, with a focus on girls with disabilities (who are the most vulnerable



among adolescents and at risk of exclusion from the formal education system as well as the entire community) from three educational institutes, focusing on their empowerment and promoting environmental awareness , through five key sustainable activities: 1....provide new educational equipment (laptops and printer) and IT literacy classes to ensure quality education for GwD and develop their skills to enter the labor market (Goal 4, 5); 2. ...Environmental education through teacher training and awareness classes for GwD and adolescents in Basra, focusing on best practices related to climate change and water management (Goal 11, 13, 15); 3. ...girls' health, through menstrual hygiene management (MHM) training for teachers and MHM sessions for GwD girls and adolescent girls in Basra (Goal 3); 4. ... Empowering girls through women's leadership dialogue sessions and reading classes, in cooperation with the local library (SDG 4); 5. ... Build and support civil society to create a market environment, by introducing innovations, creating volunteer job opportunities, and active citizen participation, by promoting offline and online volunteer activities for young people (Goal 5, 8, 10, 11).

The program aims to help 250 economically vulnerable young people, males and females, who face the risk of food insecurity. The project focuses on providing these young people with essential job skills to enhance their employment opportunities and financial prospects through four months of online sessions in digital English and computer skills, as well as one month of in-person courses on entrepreneurship and life skills topics. , and financial inclusion.
